The Reference System is BEREC's NN monitoring standard for Europe. The project, implemented by alladin-IT & zafaco, is finished. It is now available for national implementations.



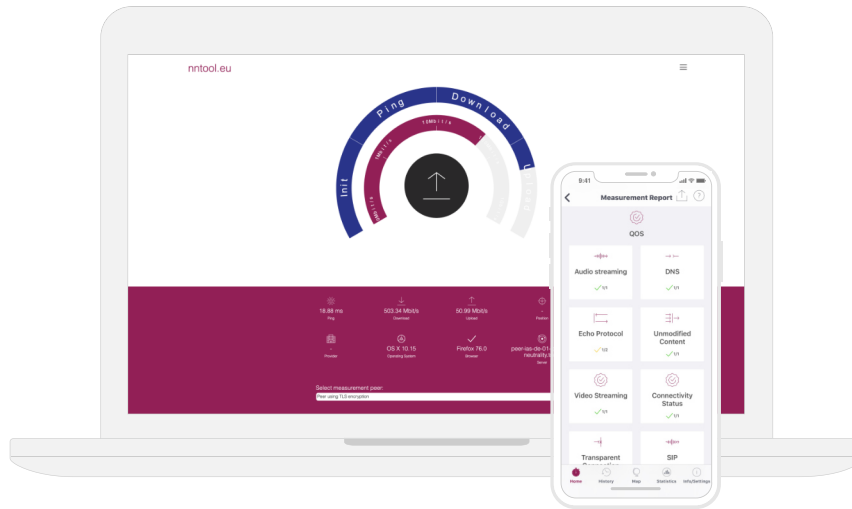

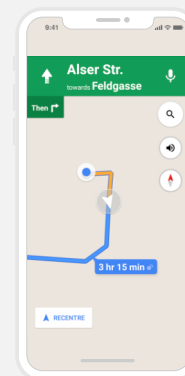
Result graph, PDF report and history

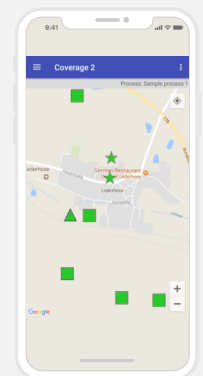

Select points for individual worklist



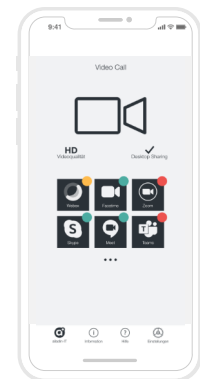
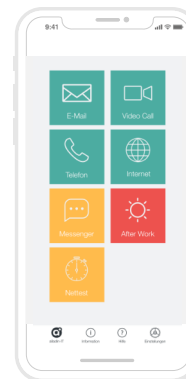
